Speaker and Moderator Bios

Helga Fogstad, Executive Director, PMNCH

Helga Fogstad is the Executive Director of the Partnership for Maternal, Newborn & Child Health (PMNCH). Strongly committed to human rights, public health and gender issues, Ms. Fogstad has extensive experience in forging partnerships and consensus building to promote the health and well-being of women, children and adolescents. She is a health economist with more than 30 years of public health experience, including many years in developing countries at sub-national and national levels, as well as at the global level within multilateral and bilateral agencies. Prior to her time at PMNCH, Ms. Fogstad was the



Director of the Department of Global Health, Education and Research at the Norwegian Agency for Development Cooperation (Norad). In Norad, she guided Norway's efforts to promote the rapid scale-up of proven cost-effective interventions with a special focus on the health MDGs for women and children. In this capacity, she was actively engaged in political mobilization and advocacy initiatives, particularly surrounding the implementation of the Global Strategy for Women's and Children's Health, and related UN commissions on information and accountability, and on life-saving commodities for women's and children's health. In this capacity she often represented Norway in global health structures and events.

Zulfiqar A Bhutta, Founding Director, Institute for Global Health and Development, AKU and Co-Director, Centre for Global Child Health, Sick Kids Hospital, and BRANCH Consortium.

Dr. Zulfiqar A. Bhutta is the Inaugural Robert Harding Chair in Global Child Health at the Hospital for Sick Children, Co-Director and Director of Research at the SickKids Centre for Global Child Health and Founding Director of both the Centre of Excellence in Women and Child Health, and Institute of Global Health and Development at Aga Khan University. Dr. Bhutta is a Distinguished National Professor of the Government of Pakistan, co-Chair of the Maternal and Child Health oversight committee of World Health Organization Eastern Mediterranean Region, and the Coalition of Centres in Global Child Health Chairman. He is a leading voice for health professionals supporting integrated maternal, newborn and child health globally. Dr. Bhutta leads large research groups in Toronto, Karachi and Nairobi with



special interests in scaling up evidence-based, community setting interventions and implementation of RMNCAH&N interventions in humanitarian contexts. Dr. Bhutta obtained his MBBS from the University of Peshawar and his PhD from the Karolinska Institute. He is a Fellow of the Royal College of Physicians, the Royal College of Paediatrics and Child Health, the American Academy of Pediatrics, and the Pakistan Academy of Sciences. In 2020 he was awarded the honour of Fellow of the Royal Society.

Karl Blanchet, Geneva Centre of Humanitarian Studies & BRANCH Consortium

Professor Karl Blanchet is the Director of the Geneva Centre of Humanitarian Studies, and Professor in Humanitarian Public health at the Faculty of Medicine, University of Geneva. Karl was also the co-Director of the Health in Humanitarian Crises Centre at the London School of Hygiene and Tropical Medicine. His research has focused on health system resilience and the development of priority package of health services in conflict-affected countries such as Afghanistan or during the COVID-19 pandemic.



Dr Jai K Das, Assistant Professor, Department of Paediatrics and Child Health, AKU

Dr Jai works as an Assistant Professor for the Division of Women and Child Health and is the Section Head of the Section of Public Health and Epidemiology at the Aga Khan University, Karachi. He has been actively involved in research including community and clinical based trials, population-based surveys, qualitative, mixed methods research and evidence based systematic reviews. He is also a lead author for the various Lancet series including 'Maternal and Child Undernutrition- 2013', 'Newborn and Neonatal Health- 2014', 'Stillbirth Series - 2016', 'Women's and Children's Health in Conflict Settings 2021' and Lancet undernutrition Series 2021. He is the author of more than 150 international peer-reviewed papers and contributed to more than 15 book chapters. He is also the editor of the book 'Pakistan, SDGs



and Health'. His interests are related to the use of evidence in policy and programs, including estimates of burden of disease, estimating effectiveness of various interventions, development of research capacity and the strengthening of public health.

Dr Nabeela Ali, Country Representative / Chief of Party, JSI Research and Training Institute, Inc

Dr. Nabeela Ali brings 35 years of experience working with both the government and non-government (NGO and private) sectors for effective health programming in Pakistan. As an expert in public health and systems strengthening for RMNCH and Global Health Security. She has conceptualized large projects and programs and ensured successful implementation. Dr. Ali has worked at all four levels of health systems from federal, provincial to district and community level. She is a well-respected public health leader and practitioner. She has helped design national maternal, newborn and child health policies and strategies for national and provincial health departments, and has planned and implemented complex, highly successful



public health programs considered as USAID flagship programs in Pakistan. Dr. Ali is recognized globally for her contributions in generating evidence for policy and design programs for poor and marginalized in Pakistan such as Chlorhexidine (CHX) for newborns cord care. A clinician and a public health expert, Dr. Ali holds both an MD/MBBS and an MPH. Dr. Ali is a proud mother of two sons and a daughter and is based in Islamabad.

Wais Qarani, President, Afghanistan Nurses and Midwives Council

Mr Wais Mohammad Qarani has completed his Bachelor of Science in Nursing in 2009 and Masters of Science in Nursing in 2015 from the Aga Khan University School of Nursing in Karachi, Pakistan. Mr. Qarani has extensive nursing management experience in education and healthcare provision. Since April 2011 he is serving the French Medical Institute for Mothers and Children (FMIC) in #WCHinConflict different capacities; and currently he is the "Administrator/Director" for the Division of Nursing Services. Before this, Mr. Qarani was assigned through Jhpiego as "Technical Advisor" to the Afghanistan Midwifery and Nursing Education Accreditation Board; and he has also served AKU programs in Afghanistan as



"Nurse Educator". Besides leading and facilitating various small-scale quality improvement projects, Mr. Qarani has numerous publications. As part of his voluntarily services, he has served AKU Alumni Association Afghanistan Chapter as "President" during 2017-2019. Currently, he is the President of the Afghanistan Nurses and Midwives Council.

Ellen Thom, Technical Officer, WHO Country Office Pakistan

Ellen is a Public Health Practitioner with extensive experience in managing Reproductive, Maternal, Neonatal, Child, Adolescent Health and Nutrition including Prevention of Mother to Child Transmission (PMTCT) of HIV programmes. She has a master's degree in international health obtained from Queen Margaret University, Edinburgh, Scotland. She has worked with MOH, Non-Governmental Organisations (NGOs) and UN agencies at sub national, national and global levels. Ellen is currently leading the Healthier Population Through the Life Course Cluster in WHO Country Office Pakistan.

Shafiq Mirzazada is currently the Deputy Minister for Policy and Planning at the Ministry of Public Health of Afghanistan. Before joining the government of Afghanistan, Dr. Mirzazada worked with a number of agencies of the Aga Khan Development Network in different capacities such as the Director for Academic Projects Afghanistan of the Aga Khan University, Chief Executive Officer and Country Program Director for the Aga Khan Health Service, Afghanistan, and the Aga Khan Foundation, Afghanistan.
